SECTION 3: HAZARDS IDENTIFICATION

3.1 EMERGENCY OVERVIEW

Specific Physical Form: Thixotropic paste

Odor, Color, Grade: black, very slight odor

General Physical Form: Solid

Immediate health, physical, and environmental hazards: May cause allergic skin reaction. May cause allergic respiratory

reaction. Contains a chemical or chemicals which can cause cancer. TOLUENE DIISOCYANATE (26471-62-5): Persons previously sensitized to TDI or other isocyanate may react to subsequent exposures of concentrations well below the TLV. These symptoms which can include chest tightness, wheezing, cough, shortness of breath, or asthma attack, could be immediate or delayed for several hours.

3.2 POTENTIAL HEALTH EFFECTS

Eye Contact:

SECTION 4: FIRST AID MEASURES

4.1 FIRST AID PROCEDURES

SECTION 6: ACCIDENTAL RELEASE MEASURES

8.1 ENGINEERING CONTROLS

8.2.1 Eye/Face Protection

Avoid eye contact with vapors, mists, or spray.

8.2.2 Skin Protection

Avoid skin contact. Select and use gloves and/or protective clothing to prevent skin contact based on the results of an exposure assessment. Consult with your glove and/or protective clothing manufacturer for selection of appropriate compatible materials. Do not use heat to aid in the removal of 5200 Marine Sealant. The application of heat may generate levels of Toluene Diisocyanate (TDI) in excess of the TLV.

8.2.3 Respiratory Protection
